In addition to working with other Senate Republican Leadership offices on a daily basis, Ashley served as a liaison with the business community and outside groups to strengthen relationships with Senate Republicans among a diverse set of coalitions.

From 2007-2009, Ashley served as Director of Coalitions and senior advisor for then House Republican Whip, and current Senator, Roy Blunt of Missouri. In this capacity, she worked on building issue coalitions with various industry groups, trade associations, corporations, and advocacy groups to promote and advance issues important to House Republicans. In addition she advised the Whip on legislation relevant to the business community and large outside coalitions and worked to develop legislative and communication strategies with these groups on behalf of the House Republican Leadership. This role provided Ashley the opportunity to further develop and solidify her extensive relationships and further strengthen her strong grasp on legislative procedure and process in the House.

Before joining the Republican Whip's office, Ashley was an integral part of the office of former Representative Sue Myrick (R-NC) for nine years, including serving as Chief of Staff for five years and overseeing Representative Myrick's tenure as Chairman of the House Republican Study Committee as well as her role as a Deputy Whip. As head of the Congresswoman's Washington office, Ashley oversaw all legislative, communications, scheduling, and constituent services operations and provided significant strategic advice and guidance. Ashley was also responsible for the Congresswoman's work on the Energy and Commerce Committee. In that role, she focused on energy issues, including energy efficiency standards, nuclear, hydroelectric, oil and gas, and climate change.

Prior to serving as Chief of Staff, Ashley served as Representative Myrick's Legislative Director. In this capacity, she developed and implemented the Congresswoman's legislative agenda and supervised all legislative staff. She focused primarily on issues pertaining to energy, healthcare, and telecommunications. In addition, she oversaw the Congresswoman's work on the House Rules Committee.
